Prospective purchasers are advised to refer to the sales brochure for the development for information on the development.

- (2) 根據《一手住宅物業銷售條例》第 52(1)條及第 53(2)及(3)條，－
According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance, –

第 52(1) 條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的 5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第 53(2) 條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的 5 個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的 8 個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

第 53(3) 條 / Section 53(3)

如某人於某日期訂立臨時買賣合約時，但沒有於該日期後的 5 個工作日內，就有關住宅物業簽立買賣合約，則 – (i) 該臨時合約即告終止；(ii) 有關的臨時訂金即予沒收；及 (iii) 擁有人不得就該人沒有簽立買賣合約而針對該人提出進一步申索。

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase –

(i) the preliminary agreement is terminated; (ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

The purchaser shall pay the preliminary deposit equivalent to 5% of the transaction price upon signing of the PASP. The ASP shall be signed by the purchaser within 5 working days after signing of the PASP.

- (2) 買方簽署臨時合約後 30 天內再付成交金額 5%作為加付訂金。

A further 5% of the transaction price being further deposit shall be paid by the purchaser within 30 days after signing of the PASP.

If, after applying for the 80% First Mortgage Loan, the purchaser eventually does not utilize the 80% First Mortgage Loan, the purchaser will be entitled to a "Transaction Price Rebate" equivalent to 2.5% of the original transaction price from the vendor, which will be directly applied towards settlement of part of the balance of transaction price upon completion.

- (11) 買方於決定選擇此安排前，請先向介紹之第一承按人查詢清楚按揭條款及條件、批核條件及申請手續。

The purchaser is advised to enquire with the Referred First Mortgagee on details of the terms and conditions of the 80% First Mortgage Loan, approval conditions and application procedures of the 80% First Mortgage Loan before choosing this arrangement.

- (12) 本價單所列之80%第一按揭貸款條款及批核條件僅供參考，介紹之第一承按人保留不時更改80%第一按揭貸款條款及批核條件的權利。

The terms and conditions and approval conditions of the 80% First Mortgage Loan as set out in this price list are for reference only, the Referred First Mortgagee reserves the right to change the terms and conditions and approval conditions of the 80% First Mortgage Loan from time to time as it sees fit.

- (13) 有關80%第一按揭貸款之批核與否及借貸條款以介紹之第一承按人之最終決定為準，與賣方無關，且於任何情況賣方均無需為此負責。賣方並無或不得被視為就80%第一按揭貸款之按揭條款及條件以及申請之批核作出任何不論明示或隱含之陳述、承諾或保證。不論貸款獲批與否，買方仍須按正式合約完成交易及付清成交金額餘款。

The terms and conditions and the approval of applications for the 80% First Mortgage Loan are subject to the final decision of the Referred First Mortgagee, and are not related to the Vendor (who shall under no circumstances be responsible therefor). No representation, undertaking or warranty, whether express or implied, is given, or shall be deemed to have been given by Vendor in respect of the terms and conditions and the approval of applications for the 80% First Mortgage Loan. Irrespective of whether the 80% First Mortgage Loan is granted or not, the purchaser(s) shall complete the sale and purchase in accordance with the ASP and pay the balance of the transaction price.

- (e) 「5年低息保」補貼優惠 “5-Year Low-Rate Guarantee” Subsidy Benefit

只適用於揀選第(4)(i)(A)段或第(4)(i)(B)段之付款計劃的買方及屬自然人的買方。如買方於簽署臨時合約時選擇「5年低息保」補貼優惠，住宅物業的售價(扣減所有適用折扣後)將向上調高0.5%。

Only applicable to the purchasers who select the payment plans under paragraphs (4)(i)(A) or (4)(i)(B) and who are natural persons. If the purchaser chooses “5-Year Low-Rate Guarantee” Subsidy Benefit upon signing of the PASP, the price of the residential property (after applying all applicable discount(s)) shall be increased by 0.5%.

在指定情況下，賣方將向買家補貼每月供款(「該補貼」)。該補貼受以下條款及條件規限：

Under specified circumstances, the Vendor shall provide “5-Year Low-Rate Guarantee” Subsidy Benefit (the "Subsidy") to the purchaser subject to the following terms and

conditions:

- (1) 買方須付清住宅物業之樓價餘款及按買賣合約完成住宅物業買賣。

The purchaser shall fully settle the balance of purchase price of the residential property and complete the purchase of the residential property in accordance with the ASP.

- (2) 付清住宅物業之樓價餘款之全部或部份須以香港持牌銀行提供的第一按揭貸款(「第一按揭貸款」)支付，並以住宅物業的第一樓花按揭及／或第一法定按揭作抵押。

The payment of the whole or part of the balance of purchase price is financed by a first mortgage loan ("First Mortgage Loan") provided by a licensed bank in Hong Kong and secured by a first equitable mortgage and/or first legal mortgage over the residential property.

The maximum tenor of the First Mortgage Loan shall be 30 years.

During the first five years of the tenor of the First Mortgage Loan, if the amount of any monthly instalment exceeds the specified amount, the purchaser can apply to the Vendor for the Subsidy for that month which is equal to the difference between the two, subject to a specified cap. The specified amount is the amount of monthly instalment calculated based on the terms including (a) the interest rate of 2.5% per annum and (b) the then outstanding principal of the First Mortgage Loan and (c) the then remaining tenor of the First Mortgage Loan. The specified cap is the difference between (a) the amount of monthly instalment calculated based on the terms including (i) the interest rate of 3.6% per annum and (ii) the then outstanding principal of the First Mortgage Loan and (iii) the then remaining tenor of the First Mortgage Loan; and (b) the amount of monthly instalment calculated based on the terms including (i) the interest rate of 2.5% per annum and (ii) the then outstanding principal of the First Mortgage Loan and (iii) the then remaining tenor of the First Mortgage Loan. The Vendor's calculation as to the amount of the Subsidy shall be final and binding on the purchaser.

- (5) 買方必須先繳付每月供款，並於通知每月供款金額的有關文件（如銀行結算單）發出後60日內，以指定的申請表格向賣方申請該補貼。買方需向賣方提供其要求的證明文件方為完成申請。

The purchaser shall first make payment of the monthly instalment, and apply to the Vendor for the Subsidy for that month in a prescribed application form within 60 days from the issuance date of the relevant documents (such as bank statement) advising the amount of monthly instalment. The purchaser may be required to submit such documentary proof as may be required by the Vendor for verification.

After the verification of the relevant information by the Vendor, if the purchaser is eligible for the Subsidy, the Vendor will deposit the Subsidy directly into the purchaser's bank account maintained with a licenced bank in Hong Kong (or in any other manner as the Vendor may decide) within 30 days after the submission of the application form and documentary proof.

- (7) 為免生疑問，買家在任何情況下須負責償還在該第一衡平法按揭/ 第一法定按揭下的貸款，賣方無須就未能提供或未能如期提供該補貼而令買方或相關借款人蒙受的損失承擔任何責任。

For the avoidance of doubt, the purchaser shall be liable to repay the First Mortgage Loan in all circumstances and the Vendor shall not be responsible for any loss suffered by the purchaser or the relevant borrower(s) or guarantor(s) due to failure or delay in providing the Subsidy.

- (8) 該補貼優惠將於以下情況自動終止 (a) 第一按揭貸款的首五年的還款期內被全部付清或經另一貸款再融資(不論另一貸款是否由相同銀行提供); 或 (b) 根據第一按揭貸款的條款及細則下發生違約事件。買方不會因此而獲得任何補償。

The offer of the Subsidy shall lapse automatically if (a) the First Mortgage Loan is fully repaid or re-financed by another loan during the first five years of the tenor of the First Mortgage Loan; or (b) there shall be an event of default under the terms and conditions of the First Mortgage Loan. The purchaser will not be entitled to any compensation therefor.

- (9) 「5年低息保」補貼優惠受其他條款及細則約束。

“5-Year Low-Rate Guarantee” Subsidy Benefit is subject to other terms and conditions.

Who is liable to pay the solicitors' fees and stamp duty in connection with the sale and purchase of a specified residential property in the Development

- (a) 如買方選用賣方代表律師處理買賣合約、按揭及轉讓契，賣方同意支付買賣合約及轉讓契兩項法律文件之律師費用。如買方選擇另聘代表律師處理買賣合約、按揭及轉讓契，買方及賣方須各自負責有關買賣合約及轉讓契兩項法律文件之律師費用。

If the purchaser appoints the vendor's solicitors to handle the ASP, mortgage and assignment, the vendor agrees to bear the legal cost of the ASP and the assignment. If the purchaser chooses to instruct his own solicitors to handle the ASP, mortgage or assignment, each of the vendor and purchaser shall pay his own solicitors' legal fees in respect of the ASP and the assignment.

- (b) 買方須支付一概有關臨時買賣合約、買賣合約及轉讓契的印花稅(包括但不限於任何買方提名書或轉售(如有)的印花稅、額外印花稅、買家印花稅及任何與過期繳付任何印花稅有關的罰款、利息及附加費等)。

All stamp duties on the PASP, the ASP and the assignment (including without limitation any stamp duty on, if any, nomination or sub-sale, any special stamp duty, any buyer's stamp duty and any penalty, interest and surcharge, etc. for late payment of any stamp duty) will be borne by the purchaser.

(v) 買方須為就買賣該發展項目中的指明住宅物業簽立任何文件而支付的費用

Any charges that are payable by a purchaser for execution of any document in relation to the sale and purchase of a specified residential property in the Development

All legal costs and charges in relation to other legal documents such as supplemental agreement, nomination, certifying fee for Government Lease, deed of mutual covenant and all other

title documents, search fee, registration fee, plan fee and all other disbursements shall be borne by the purchaser. The purchase shall also pay and bear the legal costs and disbursements in respect of any mortgage.
